- In case of Nursery bed, 0.06 oz of BioMantra<sup>TM</sup> Root<sup>+</sup> per 500 sq.ft. diluted in 0.44 gallons of water is recommended.
- Spray BioMantra<sup>TM</sup> Root<sup>+</sup> solution over the root zone once 15 days after sowing and next 30 days after sowing.
